This arrangement helps to ensure that the documents housed at the Library will be available to anyone with an interest in the history of the two organizations with assurances that they will be maintained in a safe and secure manner. ## **Preservation of York County Records**

One of the projects that has been a major accomplishment of our organization in the past has been the preservation of York County Records. Most recently, some of the older marriage records have been bound and preserved. We are looking into the possibility of preserving additional marriage records starting with 1877. This preservation work is done by a private firm, C.W. Warthen, under contract to the Circuit Court Clerk's office, but funded by the YPS.

## **Applying for Grants**

There are organizations which are willing to provide funds or in some cases matching funds for projects that they deem worthwhile. Some of our restoration and preservation activities fall into that category. Holly Jonak, who had been investigating the possibility of acquiring grants for some of our preservation activities, has accepted employment with Colonial Williamsburg in grant acquisition. Because of the obvious conflict of interest, she cannot continue working on grants for the Yorktown Preservation Society. However Holly has said she would be able to provide general information on the process of applying for grants if we find someone in YPS to take over this task.
